### **TEENAGE SEGMENT 1 (ONE) PROVISIONS**

- 1. Mr. R's Driving School will provide a minimum of 24 hours of classroom instruction, 6 hours of Behind-the-Wheel (BTW) instruction and 4 hours of observation time with a certified Michigan Driver Education Instructor.
- 2. Classroom instruction must be a minimum of 3 weeks in length and shall not exceed 2 hours per day. BTW instruction shall not begin until the student has received a minimum of 4 hours of classroom instruction and must be completed no later than 3 weeks after the classroom instruction has been completed.
- 3. The student must be at least 14-years and 8-months of age by the first day of a Segment 1 course. Verification by birth certificate is required.
- 4. Mr. R's Driving School will conduct BTW instruction in a dual controlled automobile that is fully insured by the Provider to cover each student enrolled in the program.

## **TERMS**

The Parent or Legal Guardian agrees to pay the total amount of \$450-520 (depending on the class) by the first day of class in the form of cash, check, Visa or MasterCard (additional credit card processing fees may apply) unless other arrangements are made.

If a student is absent from class they must attend a "make-up" class to be arranged with the instructor

In the event of a driving appointment cancellation, a cancellation fee of \$10.00 may be charged if 24 hours advance notice is not given.

The student must complete 6 hours of BTW driving and 4 hours of observation to be arranged by instructor and the student.

We reserve the right to not begin BTW training until agreed upon payment is received.

#### REQUIREMENTS TO PASS THE COURSE

## Pass the State of Michigan Test (70%)

The Student will be allowed up to 3 attempts to pass the State Exam, which requires a score of at least 70%

The Student must pass ALL BTW Performance Objectives, per the Driver Education Provider and Instructor Act (DEPIA), at the instructor's professional discretion with a satisfactory or higher grade

If the student does not complete all requirements and pass the written test within 6 months of taking the class, they may be marked as failed and be required to enroll in Segment One again and may be required to pay class tuition again

Upon successful completion, (pass the state test at 70%, attendance for 24 hours of class, proficiently driving after 6 hours of BTW,4 hours of observation) the student will be issued a "MICHIGAN DRIVER EDUCATION CERTIFICATE OF COMPLETION SEGMENT ONE" certifying completion of the requirements of the Michigan Department of State. A \$10.00 replacement fee will be assessed for issuing a new certificate.

Segment One Certificate Of Completion will be issued when tuition is paid in full and all class requirements are met.

#### REFUND POLICY

If for any reason you decide to withdraw from the course before its completion, your refund will be based on the following pro-rated schedule:

- A. Before the first class, 100% of tuition is refunded
- B. During the first two classes, if no Behind-the-Wheel lessons were taken, 90% of the total tuition is refunded.
- C. During the third and forth classes, if no Behind-the-Wheel driving lessons were taken, 75% of total tuition is refunded.
- D. During the first four classes, if one hour of Behind-the-Wheel driving has been completed, 50% of total tuition is refunded.
- E. During the first four classes, if two or more hours of Behind-the-Wheel driving has been completed, or at any time after the fifth class, no refund will be given.

## Parent waiver agreement for individualized on-the-road instruction.

Section 33 (d) of the Driver Education Provider and Instructor Act requires that at least two students must be in a vehicle during BTW instruction unless a parent waives this requirement in writing. I, the Parent/Legal Guardian of the Student, waive this requirement. I understand that my son/daughter must still complete at least 4 hours of observation time as a passenger in a driver education vehicle being driven by another driver education student.
